

## Suggestions for Nominating Deacons

Our Deacon Nominating Committee (in accordance with the method of selecting Deacons as approved by our church) requests that you submit names of those men you feel are qualified to fill the important office of Deacon.

### Biblical Qualifications

The office of Deacon is one of the highest calls to service offered by our church. Before making your nominations, please review these **biblical qualifications** which give requirements for **general reputation, spiritual attributes** and **family relationships**.

**Acts 6:3:** "Brothers, choose seven men from among you who are known to be full of the Spirit and wisdom." (Read Acts 6:3-8.)

**I Timothy 3:8-13:** "Deacons, likewise, are to be men worthy of respect, sincere, not indulging in much wine, and not pursuing dishonest gain. They must keep hold of the deep truths of the faith with a clear conscience. They must first be tested; and then if there is nothing against them, let them serve as deacons. In the same way, their wives are to be women worthy of respect, not malicious talkers but temperate and trustworthy in everything. A deacon must be the husband of but one wife and must manage his children and his household well. Those who have served well gain an excellent standing and great assurance in their faith in Christ Jesus."

### Practical Standards

Certain **practical standards** are also recognized by our church. Each deacon should:

- (1) Be a committed, Bible-believing Christian.
- (2) Support the total ministry and program of our church.
- (3) Be actively involved in the ministries and worship opportunities of our church (morning and evening).
- (4) Abstain from the use and personal promotion of alcoholic beverages.
- (5) Give a minimum of a tithe of his income through our church.
- (6) Be a consistent personal witness to the unsaved.
- (7) Have been an active member of Shades Mountain Baptist Church at least one year.
